REENTRY SERVICES ARE PROVIDED BOTH PRE AND POST-RELEASE AND INCLUDE: CASE MANAGEMENT, WORKFORCE DEVELOPMENT, MENTORING, FINANCIAL LITERACY, FAMILY REUNIFICATION, AND ASSISTANCE SECURING BASIC NEEDS. ADDITIONALLY, BCPS WORKS TO EDUCATE EMPLOYERS ABOUT THE BENEFITS OF HIRING RETURNING CITIZENS AND PROVIDES ONGOING EMPLOYMENT SUPPORT. IN 2022, BCPS PROVIDED REENTRY SERVICES TO 873 RETURNING CITIZENS THROUGH OVER 7,067 CONTACTS WITH PROGRAM CASE MANAGERS. BCPS ALSO SERVES AS THE OFFICIAL HUB FOR THE PARDON PROJECT OF BERKS COUNTY, A PROGRAM THAT SEEKS TO NOT ONLY RAISE AWARENESS OF THE PARDON PROCESS, BUT ALSO TO MATCH TRAINED VOLUNTEER PARDON COACHES
